## **Cancellation**

**It is additionally agreed that should the event be canceled, a notice of 3 months must be given by hirer(s) listed above, and a fee of 15% of the total piece will be paid to Regal Carriage Inc. If the hirer(s) give notice of less than three months, a fee of 50% of the total cost will be paid to Regal Carriage Inc.**

**Should Regal Carriage Inc. need to cancel due to operational problems, or if other unforeseen problems arise, notice will be given to enable the hirer to make alternative arrangements. Since this is a weather permitting activity we recommend that you make alternative transportation arrangements. Furthermore, in this event all payments and deposits, less 15% will be refunded within a week of the cancellation.**

**The customer will get a refund due to inclement weather; rain, thunder, snow, extreme heat (above 90F) extreme cold (below 30F) hail, ice, etc, less 15% deposit. Regal Carriage will drive the route beforehand, and determine the safest route for the client and our horses. The route will exclude bridges, ramps, expressways, highway, train trestle.**
